Olivewavz Cat/Kitten Sales Agreement

A NON-REFUNDABLE DEPOSIT of \$500.00 is required to reserve a cat/kitten. The deposit will only be refunded if the Breeder (OLIVEWAVZ) cancels the contract. OLIVEWAVZ reserves the right to cancel this contract at any time before delivery of cat/kitten and refund any monies paid to OLIVEWAVZ with no further obligation to the Buyer.

OLIVEWAVZ makes no representations or guarantees whatsoever as to the physical features, attributes, personality or temperament of said cat/kitten.

Within 3 days of receipt of the cat/kitten, the Buyer may, at his option and sole expense, have the cat/kitten examined by a licensed veterinarian. If such veterinarian certifies to OLIVEWAVZ within one week of such examination and/or any blood test, a <u>serious</u> defect in the health of the cat/kitten, OLIVEWAVZ must be notified immediately, and the cat/kitten must be returned with a copy of the veterinarian report. In such case, upon receipt of the cat/kitten and veterinary report of illness, OLIVEWAVZ will refund all moneys paid to OLIVEWAVZ. Upon no circumstance shall OLIVEWAVZ be responsible for payment of any medical treatment provided to the cat/kitten by the Buyer during the time in which the cat/kitten is in the Buyer's possession, nor shall OLIVEWAVZ be responsible for any other miscellaneous expenses, i.e.; transportation, shipping etc. In the event of the death of the cat/kitten (ownership of a week or less), <u>Buyer MUST provide a copy of complete autopsy/necropsy report in order to receive a refund</u>.

OLIVEWAVZ agrees to replace the cat/kitten in the event the cat/kitten dies of a <u>congenital defect</u> within the first year of its life (not first year of ownership). A <u>veterinary autopsy/necropsy MUST be provided to verify cause of death and in order to receive another cat/kitten</u>. OLIVEWAVZ will replace the cat/kitten with another cat/kitten of similar quality when available. If Buyer does not want a replacement cat/kitten, OLIVEWAVZ will have no further obligation towards Buyer and no refund will be given.

A NOTE ABOUT FIP (Feline Infectious Peritonitis) Researchers are still not sure what causes FIP and whether or not is it environmental or genetic. Most conclude that there are some genetics involved along with environmental triggers. Up until recently, it was always considered a fatal disease. However, there is a cure now available. If your vet suspects FIP, please contact me ASAP for consultation about how to obtain medicine as many vets still do not know there is a cure. For the purpose of this contract only, it will be considered a congenital defect and thus the previous paragraph applies.

OLIVEWAVZ will register the litter of the cat/kitten with The Cat Fanciers Association, Inc. It is up to the Buyer to register the cat/kitten with The Cat Fanciers Association, Inc. Registration papers will be provided to the new owner at the time of sale.

On a case by case basis, if for any reason the Buyer of the kitten needs to return the kitten to OLIVEWAVZ during the first month of ownership, OLIVEWAVZ will accept the kitten back. All monies paid by the Buyer for the kitten will be returned with the exception of the \$500 deposit. The Buyer will also be required to get the kitten tested for Feline Leukemia/FIV at the Buyer's cost and provide proof of a negative result before the kitten will be accepted back by OLIVEWAVZ if the kitten/cat was exposed to other cats in the Buyer's home. OLIVEWAVZ is not responsible and will not reimburse the buyer for any money spent on the kitten while in the Buyer's care to include, but not limited to, veterinary services.

The Buyer agrees to give the cat/kitten the best possible care.

The Buyer will at no time allow the cat/kitten outside unattended.

The Buyer agrees not to declaw the cat/kitten.

Vaccinating against FeLV (Feline Leukemia) and FIP (Feline Infectious Peritonitis) is not recommended. If the Buyer and their Veterinarian decide to give either of these vaccines, OLIVEWAVZ shall not be held responsible in any way. No refund or replacement will be given regardless of the cause/time frame of death of cat/kitten if cat/kitten received either of the above mentioned vaccines.

The Buyer will not give, lease, loan or sell the cat/kitten to another person, institution, animal shelter, cattery or any other entity without notifying OLIVEWAVZ first. If permission to transfer the cat/kitten is granted by OLIVEWAVZ, the new owner(s) must agree to abide by the terms of this agreement. OLIVEWAVZ can/will help facilitate a new home for the cat/kitten if needed. If there are no immediate prospects for a new owner and time is of the essence, OLIVEWAVZ will personally house the cat/kitten until a new owner is found.

The Buyer will not voluntarily cause or ask an agent to cause the untimely demise of the cat/kitten without a veterinarian's certification that such is necessary for veterinary or humane reasons.

Please note that during times of stress, such as going to a new home, cat/kittens can exhibit temporary signs of illness which may include: sneezing, runny nose, watery eyes, diarrhea and/or constipation. To help reduce the signs of stress feed the cat identical food as the breeder, and offer bottled water, as well as taking reasonable measures to reduce stress. You can do this by slowly introducing them to the house and the members of the household, as well as limiting the time they are with strangers, children and other animals.

Cornish Rex are very sociable animals which enjoy being with humans and suffer from lack of attention. Please take the time to play, talk and love your Cornish Rex. Remember the more love and attention you give them, the more you will get in return.
